NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 ILCA Class Rules will apply. [DP]
- 1.3 Under RRS 87, ILCA Fundamental Class Rule ***Sail Identification*** will not apply.
- 1.4 The sailing instructions may also change other racing rules.
- 1.5 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing instructions, and supplementary sailing instructions that will be posted to the official notice board online <https://theclubspot.com/regatta/Uh7xCX1V0g>

2 ADVERTISING

- 2.1 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies. [DP]

3 ELIGIBILITY AND ENTRY

- 3.1 **No competitor age restrictions will be in place.**
- 3.2 The regatta is open to all ILCA Dinghies.
- 3.3 Eligible boats may enter by registering online through Clubspot, paying the entry fee in its entirety, and completing the online liability waiver.

- 3.5 A maximum of 40 entries will be accepted.
- 3.6 Late entries will be accepted under the following conditions:
 - Completing all conditions of NOR 3.3
 - Paying an additional \$5 late fee
 - (The late fee may be waived if a suitable dog treat is accepted by Dax)

4 FEES

- 5.1 Required fees are as follows:

ILCA Dinghy (all Rigs)	\$5 (+ additional \$5 late fee if applicable)

5 SCHEDULE

- 5.1 Dates of racing: 10/11/2020
- 5.2 Number of races: No maximum
- 5.3 The scheduled time of the warning signal for the first race is 1030.
- 5.4 On the last scheduled day of racing no warning signal will be made after 1500.
- 5.5 Registration closes 0800, 10/11/2020
- 5.6 Late Registration closes 1030, 10/11/2020
- 5.7 Competitors meeting posted as part of the Sailing Instructions via video.

NOTICE OF RACE

5.8 No in person meeting will be held.

5.9 Lunch will not be provided and there will be no break ashore for lunch.

6 SAILING INSTRUCTIONS

6.1 The sailing instructions will be posted on 10/10/2020 before 1800 on the official notice board.

7 VENUE

7.1 The intended racing area is Wayzata Bay.

7.2 Face coverings are required at all times while ashore, including on docks / launch ramps. [DP]

7.3 Physical distancing must be maintained at all times. [DP]

7.4 All competitors must wash or sanitize their hands thoroughly before handling others equipment, including clearing the ramp of others launch equipment. [DP]

7.5 All competitors are to minimize time on shore as much as possible. [DP]

7.6 Competitors that can arrive by water (directly to the course or docks) from other launching venues by sailing or towing are expected to do so. [DP]

7.7 Boats may be stored overnight only upon request and must follow the timing and direction of WS personnel for derigging, storage, rigging, and launching. [DP]

7.8 No gatherings of three or more will be permitted ashore, unless for the purposes of hearing a protest. [DP]

7.9 All competitors must follow the venue map included in SI Attachment B for unloading, loading, rigging, and launching. [DP]

7.10 Only WS Staff, staff of other confirmed sailing schools/centers, volunteers, and competitors will be allowed on site. All other support personnel who wish to exit their vehicle must stay within the designated areas. [DP]

8 THE COURSES

8.1 The courses will be standard Windward Leeward or Olympic courses.

8.2 Diagrams will be provided in SI Attachment C, showing the courses, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.

9 PENALTY SYSTEM

9.1 Decisions of the protest committee will be final as provided in RRS 70.5.

9.2 The protest committee (PC) will be made up of one competitor of the protester's choice, one competitor of the organizing authority's choice, and one competitor of the other two PC members' mutual agreement.

9.3 Protests will be held in person, physically distanced in an outdoor setting.

9.4 Competitors are encouraged to settle all protests on the water in accordance with RRS 44 to avoid increased COVID-19 risk to competitors and Protest Committee members.

9.5 Protest hearing participants will be limited to the involved *Parties* (RRS Definitions) and the Protest Committee only.

10 SCORING

10.1 The scoring system is as follows: RRS Appendix A

10.2 One race is required to be completed to constitute a series.

10.3 (a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.

(b) When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12 PRIZES

Prizes will be given as follows: Whatever Bruce Martinson gives us from his collection and deems appropriate, or Matthew Zupon finds at Axeman. The overall winner regardless of rig choice will have their name added to the NUMB perpetual trophy. Others may receive other things. Or not.

13 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
