In 1978, my grandparents, Pat and Angie Kabris, packed up the family and headed for Lake of the Woods after reading an article about LOWISA in SAIL magazine. Their first regatta was well attended (capped at 130 boats), drawing sailors of all skills levels from as far away as Oklahoma and the US East Coast. Electronics were non-existent, scoring was manual and the days could be excruciatingly long in their sluggish Ericson 23. They had never raced a day in their lives and LOWISA 11 presented them with numerous challenges, but they quickly realized that it would be the beginning of an incredible family tradition.

I remember hearing stories from a very young age about LOWISA, a mythical wilderness sailing event in Canada. After torturing my family as a 1 year old on LOWISA, I was relegated to Opti and J22 racing on

Lake Minnetonka in my early years. I vividly remember the arrival a J29 when I was 9 years old and thinking that it must be the biggest sailboat in the world. My Grandpa and I built incredible memories fixing the boat up while it was tied on a mooring ball in front of their house on Lake Minnetonka. We re-strung halyards, replaced worn out cleats and re-built winches - a little boys dream! I didn't know it at the time, but we were gearing to head back to LOWISA for first time in years, and my life was about to change.

Notice of Race

1 RULES

1.1 The regatta will be governed by the rules as defined in the current edition of The Racing Rules of Sailing (RRS), as published by World Sailing.

2 ELIGIBILITY AND ENTRY

- 2.1 The LOWISA Sailing Regatta is open to all sailboats as defined by the RRS.
- 2.2 Competitors will be members in good standing of the CYA or the US Sailing Association (a card is the normal method of proof).

3 REGISTRATION

- 3.1 To be eligible for scoring, participants must be registered.
- 3.2 The deadline for online registration, event ticket purchase, and payment is August 2nd, 2019.
- 3.3 In person registration, check-in and materials pick-up will take place Saturday August 3rd, 2019 1-4pm at Northern Harbour, Kenora.

4 FEES

4.1 Required fees are as follows for all racing boats:

\$125 Early: Online June 16th, 2019 - June 30th, 2019

\$175 Regular: Online July 1, 2019 - August 2nd, 2019

\$250 Late Entry: In-Person August 3rd, 2019

4.2 Wristbands for all Social Activities:

\$150 Early: Online June 16th, 2019 - June 30th, 2019

\$175 Regular: Online July 1, 2019 - August 2nd, 2019

\$200 Late Entry: In-Person August 3rd, 2019

6 VENUE

6.1 Racing will take place on Lake of the Woods in Ontario, Canada.

7 PENALTY SYSTEM

7.1 RRS 44.1 will apply.

8 SCORING

- 8.1 The Low Point scoring system of RRS will apply.
- 8.2 One race is required to be completed to constitute a series.
- 8.3 (a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
 - (b) When from 4 to 6 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9 COURSES

- 9.1 Full courses will be set out in the Sailing Instructions and online prior to the event.
- 9.2 Any maps provided by LOWISA are for planning purposes only and are NOT for navigation purposes. Written instructions take precedence over drawn courses. LOWISA recommends current federal publications; racing instructions should be transferred to the actual navigational charts for use on the LOWISA regatta. The choice of charts is strictly the choice and responsibility of the participant; LOWISA accepts no responsibility or liability for participants choice of maps.
- 9.3 Relevant Navigation Charts:

6212: Kenora to Aulneau Peninsula

6217: Ptarmigan Bay and Shoal Lake

10 MEASUREMENT

10.1 The seaworthiness, condition of the boat and equipment, and capabilities of each crew member are the sole responsibility of the Captain of each boat. LOWISA reserves the right to measure or inspect any boat, its sails, running gear and for compliance of Transport Canada required safety equipment prior to or during the regatta. It is expected that one design boats will be compliant to its Part D Class Measurement and Inventory of Required & Optional Equipment as per the One Design requirements. All boats will sail with required equipment and measurements that meet the Transport Canada minimum safety requirements and the one design, PHRF or Portsmouth ratings. In addition, all boats will carry at least two VHF radios, one of which must be audible and operational by the Captain of each boat (in the cockpit). Boats challenged by formal protest by LOWISA or any competitor will be heard by the protest committee. Transport Canada's requirements may be found on their website at the address listed below in 16.

11 SAILING INSTRUCTIONS

11.1 The sailing instructions will be available online by July 27th, 2019 at 5pm.

12 HAUL-OUT RESTRICTIONS

12.1 Keelboats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

13 RADIO COMMUNICATION

- 13.1 All LOWISA entrant vessels must have two on-board and functioning VHF radios, with at least one in good operating condition.
- 13.2 Morning Net announcements will be communicated at 9:30am on VHF channel 72. These announcements will present information on daily weather forecasts, course clarifications, evening anchorages, social event updates, and provide a time to pose questions and comments.
- 13.3 Additional communications will be made at 1800hrs informing the fleet of race results, which will also be posted on the Race Committee boat. Please tune in to VHF channel 72 for up-to-date regatta info. Please refrain from using VHF channel 72 for any other reason; use it as a LOWISA listening channel only.
- 13.4 A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones. No notices of protest will be accepted by VHF radio.
- 13.5 At other times, the LOWISA committees will monitor VHF channel 16. Participants should use VHF Channel 16 for hailing purposes only, except in an emergency. Boat-to-boat hailing, especially in anchorages, should be made using low transmit power from VHF Channel 16, and then move to another agreed upon channel for communication.

14 PRIZES

14.1 Prizes will be awarded to all divisional winners as well as the winners of the Layover Day race.

15 DISCLAIMER OF LIABILITY

15.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material boat or equipment damage or personal injury or death sustained to any person or other being in conjunction with or prior to, during, or after the regatta or any associated events or activities.

16 SAFETY

- 16.1 All entrants shall carry on board the safety equipment as required by Transport Canada. Canadian participants may be required to have a Pleasure Craft Operators Card. Non-Canadian Residents will not need a Pleasure Craft Operators Card to operate a power driven vessel in Canada if their vessel has been in Canada for less than 45 days. Full details are available by calling the Canadian Registry of Ships at 1.877.242.8770 or visiting: http://www.tc.gc.ca/marinesafety/TP/TP511/boat.htm
- 16.2 Post-Finish Safety Gear Inspections: Each boat shall be prepared to be inspected upon finishing each race. Boats may be required to present all required Transport Canada and LOWISA required safety gear. The Race Committee has sole discretion to choose which boats may be inspected. Boats failing a Post-Finish Safety Inspection shall be subject to protest and/or disqualification by the Race Committee.
- 16.3 Boats not intending to race are required to inform the committee boat prior to the start of the race and they will be scored DNS. Boats retiring from the race are required to inform the committee boat and they will be scored DNF. Boats that do not race or retire from racing that do not inform the committee boat will be scored DSQ.

17 WEATHER CONDITIONS

17.1 The decision to race, or continue to race, by any boat is hers alone. Each boat should monitor weather conditions prior to the start and for the duration of each race. The Race Committee officials may also monitor weather conditions prior to the start and throughout the duration of each race and will attempt to communicate weather projections during Morning Net announcements. Participants are ultimately responsible for determining their vessel's and crew's capabilities for racing and cruising under varying weather conditions. The LOWISA committee encourages participants to consider safety as the first and foremost priority throughout the duration of this week long event. Notify the Race Committee directly in the event that you abandon a race.

18 INSURANCE

18.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per incident or the equivalent. In addition, it is recommended that each participant purchase a personal "travel" insurance such as Blue Cross.

19 MEDIA

19.1 By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the unconditional, perpetual right and authority to publish and broadcast anywhere in the world, for any purpose and in any media, the names, images, and biographical information relating to the crew and photographs, video footage, and audio recordings taken of the boat and its crew prior to, during, and after the regatta without compensation. By submitting an entry form, the skipper acknowledges and accepts the media conditions referred to herein, and grants the rights referred to herein on behalf of all his crew members.

Sailing Instructions

LOWISA 54

Sunday, August 4th - Saturday, August 10th

1 RULES

- 1.1 The regatta will be governed by the Rules as defined in The Racing Rule of Sailing (RRS), latest edition, the prescriptions of the Canadian Yachting Association, the rules of one-design fleets entered, the rules of the Performance Handicap Racing Fleet (PHRF) of the Lake Winnipeg and Lake of the Woods, the rules of Portsmouth for planning hulls and LOWISA as modified by these Sailing Instructions ("SI's") and the interpretations of the LOWISA Race Committee. Questions about these sailing instructions must be submitted in writing; questions and their answers will be communicated to all competitors by way of notice.
- 1.2 Only the measurement Rules of the participating classes will apply.
- 1.3 For multi-hull classes Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required.
- 1.4 In cases of conflicts between these Sailing Instructions and any other document that governs the event, these Sailing Instructions shall take precedence.

2 ENTRIES

- 2.1 All sailboats that are registered and have paid the registration fees are eligible to participate in the LOWISA regatta. The regatta is open to all classes.
- 2.2 Entrants will be assigned to a fleet at the discretion of the race committee.

3 NOTICES TO COMPETITORS

- 3.1 Before registration, posted on the official LOWISA website.
- 3.2 During registration, posted on the official LOWISA notice board at registration.
- 3.3 Between 8:00AM August 4th and the time of the last boat to finish on August 10th, notices to competitors will be communicated in anchorage and on the water in accordance with the following procedure:

Flag 'L' hoisted by the race committee boat over a numeral pennant means the notice numbered herewith will be delivered, either in writing or orally, when you come within hail and request it. This signal will remain displayed for the balance of the day or until a new notice is posted. Notices will be numbered consecutively starting at #1 each day. By coming within hail to get delivery of the current notice, a competitor may also obtain delivery of any preceding notice.

- 3.4 A competitors' meeting will be held at 6:00PM on August 3rd at Northen Harbour for the purpose of introducing the race officials, describing the race committee vessels and to announce the correct time.
- 3.5 LOWISA committees will monitor VHF Channel 16. Neither the PRO nor the Race Committee will respond to race related questions via VHF radio. (The PRO will may make special announcements in the event of an emergency or a postponement/abandonment of a race. These announcements will be initiated on the hailing frequency, VHF Channel 16, and then be announced on VHF Channel 72). Participants should use VHF Channel 16 for hailing purposes only, except in an emergency. Boat-to-boat hailing and communications, especially in anchorages should be made using low transmit power from VHF Channel 16, and then move to another agreed upon channel for continuing the communication.

4 CHANGES IN SAILING INSTRUCTIONS

4.1 Any change in the sailing instructions will be posted or communicated before 9:00AM on the day it will take effect, except that any change in the schedule of races will be posted or communicated by 9:00PM on the day before it will take effect.

5 SIGNALS MADE IN ANCHORAGE

- 5.1 Signals made in anchorage are deemed to be made 'ashore'. They will be displayed on the race committee boat.
- 5.2 When flag "AP" is displayed in the anchorage aboard the RC boat and prior to 9:00AM, it indicates races are "postponed", stay in the anchorage until "AP" is lowered. The "Warning" will be not less than 30 minutes after lowering.
- 5.3 When "AP" over code flag "A" is displayed, racing has been cancelled for the day.

6 SCHEDULE OF RACES

- 6.1 For the LOWISA Regatta six races are scheduled; one each day, Sunday, August 4th through Saturday, August 10th with the exception of Layover Day on Wednesday, August 7th.
- 6.2 The Layover Day Race Series on August 7th is a stand-alone race series with its own SI's and is not a part of the main LOWISA Regatta.
- 6.3 The time of the first warning signal for the LOWISA Regatta series is 11:00AM each day.

7 DIVISIONS

- 7.1 The Race Committee may divide fleets. It is anticipated that there will be a Working Sails Fleet Division, a Spinnaker Fleet division and a Dinghy/Multi-Hull/Planing Fleet Division.
- 7.2 Flags used to identify each division at their warning will be square in shape with the division number on a white background.
- 7.3 The fleet divisions and assignments will be ready by the end of registration on August 4th. Hull numbers will be provided by the Race Committee.

8 RACING AREA

- 8.1 The racing area will be Lake of the Woods, Ontario and will be as described and shown on the chart excerpts provided. These chart excerpts are for course demonstration only and are not for navigation purposes. These course descriptions are intended to identify the race course by a sequence of mandatory marks (buoys, islands) and general direction between marks. They are not intended to ensure the safe navigation between the marks and through the course. Lake of the Woods has many hazards below the water's surface. It is the responsibility of the skipper of each boat to use the latest navigation maps issued by the Canadian Hydrographic Service, either in paper or digital format, to provide safe passage through the race course. Do not use course diagrams or these course descriptions or instructions, for navigation purposes. Navigators should use Canadian Hydrographic charts 6212 and 6217.
- 8.2 In the case of a discrepancy between the charts and the SIs, the SIs shall prevail.

9 THE COURSE

9.1 The courses to be sailed, including the order in which marks are to be passed, and the side on which each mark is to be left are described in Appendix A - Courses. The course will be as prescribed by the Race Committee and as indicated at the Skippers' Meeting. Changes on the water will be determined by the Race Committee and communicated by the PRO by the international shapes flown on the RC Yacht.

10 MARKS

10.1 Marks of the courses, with the exception of the starting mark, the finishing mark, and, if set, the windward and offset marks, which shall be yellow or orange spheres, are natural features, yellow spheres and navigational buoys as shown in Appendix A.

11 THE START

- 11.1 Boats are required to check in by sailing past the committee boat prior to the start sequence.
- 11.2 Boats not intending to race are required to inform the committee boat prior to the start the race and they will be scored DNS.
- 11.3 Boats retiring from the race are required to inform the committee boat and they will be scored DNF.
- 11.4 Boats that do not race or retire from racing that do not inform the committee boat will be scored DSQ.
- 11.5 The starting line will be between a staff displaying a RC flag on the race committee boat at the starboard end and the port end starting mark.
- 11.6 Races will be started as follows:

- 11.7 Divisions may be started in any order.
- 11.8 The warning signal for each succeeding class shall be made one minute after the starting signal of the preceding class.
- 11.9 Boats whose warning signal has not been made shall keep clear of the starting area.
- 11.10 The PRO may at his discretion add an up-wind offset mark to facilitate clearing of the start line for subsequent divisions. When the race committee displays a red flag no later than with the first warning signal of a given race, it shall mean that the course is modified to include a windward mark to be left to port immediately after the start. When the race committee boat displays two red flags in the above manner, it shall mean that the course is further modified to include an offset mark to be left to port immediately after the windward mark. Should the one or two flags so displayed be green, the said mark(s) shall be left to starboard.
- 11.11 Should the race committee boat display flag "L" under flag "AP" on the water, the starting area will be replaced by that where the race committee will lower flag "L" (with one sound signal). Marks located between the old and new starting areas will be removed from the course described in sailing instruction #9.

12 THE FINISH

- 12.1 The finish line will be that point on the race committee boat flying the RC flag (or all blue flag) as the starboard end and a start mark at the port end.
- 12.2 Shortened courses will be indicated by flag "S" (a white flag with a blue square in the center, with repeated sound signals).
- 12.3 Boats who fail to finish by 6:30PM or within two hours from the first boat to finish, whichever comes first, will be provided estimated finish placing's in their current order. This changes rule 35. It is the intention of the race committee to shorten courses when appropriate and to abandon those races where the leader cannot finish by 4:30PM.

13 ARBITRATION, PROTESTS AND REQUESTS FOR REDRESS

- 13.1 Protest forms are available at the Registration Tent or from the RC boat in the anchorage. Protests shall be delivered there within the protest time limit.
- 13.2 For all Fleets, the protest time limit is 60 minutes after the race committee boat has returned to the anchorage following the last race of the day. The same protest time limit applies to all protests by the race committee and jury to request redress. This changes rules 61.3 and 62.2.

- 13.3 Notices will be posted in the anchorage within 5 minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. The location will be determined and made public. Hearings will be held at that location in the anchorage beginning at the times and/or in the order indicated in the notices.
- 13.4 Notices of protests by the race committee or jury will be posted to inform boats under rule 61.1(b).
- 13.5 Breaches of instructions 11.5 and 16 will not be ground for protest by a boat. This changes rule 60.1(a). Penalties for these breaches may be less that disqualification if the jury decides.
- 13.6 On the last day of the regatta, a request for reopening a hearing shall be delivered:
 - a) Within the protest time limit if the party requesting reopening was informed of the decision on the previous day;
 - b) No later than 30 minutes after the part requesting reopening was informed of the decision on that day. This changes rule 66.

13.7 Arbitration

- a) Only alleged violations of RRS Part 2 Rules can be arbitrated.
- b) Arbitration is a short hearing (3 to 5 minutes), at a location to be advised of, immediately after a protest has been filed there, with one representative from each boat and the Arbitrator, usually the PRO.
- c) Representatives of involved boats shall both proceed to the point of arbitration after the last race of the day within 1.25 hours (or sooner, if the protest is being filed sooner) following the docking of the RC boat after the race where the alleged incident occurred. Failure of representatives of involved boats to timely arrive at the arbitration location may result in referring the issue to a hearing by a protest committee.
- d) No witnesses are permitted in arbitration hearings.
- e) When an arbitrator is unable to determine if/which boat broke a rule, or when the representatives of boats do not accept the arbitrators ruling, the issue will be referred to a protest committee for hearing. Once concluded, an arbitration hearing shall not be reopened for any reason.
- f) When an arbitrator's "penalty" ruling is accepted by the parties, a penalized boat shall receive a minimum penalty of 2 points, or a 20% penalty as described in RRS 44.2(c), whichever is greater. Accepting a penalty in arbitration is voluntary and cannot be grounds for redress or be appealed.

14 SCORING

- 14.1 A PHRF handicapping system will be used. A Portsmouth conversion may be used if necessary.
- 14.2 Each boat will be assigned a 'time-on-time' correction factor based of the data submitted on the Handicapping Form as may be requested by the Notice of Race.

14.3 The Low Point scoring system of Appendix A will apply with five races scheduled, of which three races shall be completed to constitute a series. If four or less races are completed, each boat's total score will be the sum of her scores for all races.

15 PRIZES

15.1 Trophies are available to the first yacht of its division. Prizes will be awarded to the top three positions of each Fleet where there are at least five participants. Perpetual trophies listed at the back of the LOWISA handbook will also be awarded.

16 DISCLAIMER OF LIABILITY

- 16.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material boat or equipment damage or personal injury or death sustained to any person or other being in conjunction with or prior to, during, or after the regatta or any associated events or activities.
- 16.2 Competitors agree to hold harmless and keep indemnified LOWISA, Sail Manitoba and the Canadian Yachting Association (CYA), their sponsors, their organizers and their respective agents, officials, servants, and representatives, from and against all claims, actions, costs, expenses, and demands in respect to death, injury, loss or damage to the competitor's property, however caused, arising out of or in connection with Competitor's taking part in the event, notwithstanding that the same may have been contributed to or occasioned by the negligence of the same bodies, or any of them or their agents, officials, servants, or representatives. Competitors shall further understand and agree that this Release is binding upon them, their heirs, executors and assigns.

Courses

LOWISA 54 - Appendix A

These course descriptions are intended to identify the race course by a sequence of mandatory marks (buoys, islands) and general direction between marks. They are not intended to ensure the safe navigation between the marks and through the course.

Lake of the Woods has many hazards below the water's surface. It is the responsibility of the skipper of each boat to use the latest navigation maps issued by the Canadian Hydrographic Service, either in paper or digital format, to provide safe passage through the race course. Do not use course diagrams or these course descriptions or instructions, for navigation purposes.

The required Canadian Hydrographic Service charts for LOWISA 54 are:

6212: Kenora to Aulneau Peninsula 6217: Ptarmigan Bay and Shoal Lake

Race 1 - August 4th, 2019

Start: Southeast of Allans Island | Finish: North of Eagle Pass 20.3 NM Navigation Charts: 6212 - Kenora to Aulneau Peninsula

Proceed Southeast leaving Lunny's Island to starboard

Proceed Northeast rounding buoy EA4 and island immediately to it's southeast (with 59ft depth marker to the east) to starboard

Proceed south southwest leaving Mazies Island to starboard

Proceed south leaving Strawberry island to starboard

Proceed southwest leaving Slate Island, Gaherty Island and buoy EJ5 to starboard

Proceed north leaving Manitou Island to starboard

Head northeast leaving Kipling Island to starboard and Survey Island to port

Proceed east southeast rounding Copper Island to port

Proceed North rounding 2 unnamed island approximately 0.5 miles northeast of Copper Island (one with 3ft depth marker to the southeast and one with 11ft depth marker to northwest) to starboard

Sailing Instructions August 7th, 2019

1 RULES

- 1.1 The regatta will be governed by the Rules as defined in The Racing Rules of Sailing, latest edition and the rules of Performance Handicap fleet (PHRF), (except as any of these are altered by these sailing instructions).
- 1.2 The prescriptions of the Canadian Yachting Association will apply.
- 1.3 For Catamaran classes Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required.
- 1.4 In cases of conflicts between these Sailing Instructions and any other document that governs the event, these Sailing Instructions shall take precedence.

2 ENTRIES

- 2.1 This is a closed event and open only to registrants of the week-long LOWISA 54 Regatta. Boat owners/skippers shall be members of the CYA or US Sailing association. (All paid entrants of LOWISA 54 are automatically members of the CYA). All classes from the week-long LOWISA 54 Regatta are invited to participate. Competitors must meet all ownership and class membership requirements and must complete all aspects of the registration process to become official participants; to be eligible for scoring, entrants must register.
- 2.2 All LOWISA Regatta entrants will be started based on their fleet assignment; mono-hulls with spinnakers, mono-hulls without spinnakers (working class), and multi-hulls/planing hulls. Minimum fleet size is 3 boats. Based upon the number of entrants, the Race Committee or LOWISA reserves the right to amalgamate, cancel, subdivide or rearrange divisions or the number of starts for the Regatta. The Race Committee's or LOWISA's decision on the division in which a competing yacht will be scored is final and not subject to protest.

3 NOTICES TO COMPETITORS

3.1 Notices to competitors will be described at the competitors meeting. Because of the remote regatta venue, printing and posting may not be possible.

4 CHANGES TO SAILING INSTRUCTIONS

4.1 Any change to the Sailing Instructions described and discussed at the Competitors' Meeting including notification for simultaneous starts (see Paragraph 7.3), if required.

5 SIGNALS MADE ASHORE

- 5.1 Signals made ashore will be displayed on the flag staff at the Competitors Meeting.
- 5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes' in the Race Signal AP.
- 5.3 When flag AP over code flag "A" is displayed, racing has been cancelled for the day.
- 5.4 Code flag "L" displayed with one (1) sound signal indicates a Notice to Competitors or a change in the Sailing Instructions has been posted at the Competitors' Meeting.

6 SCHEDULE

- 6.1 All interested classes shall race on Wednesday, August 7th, 2019.
- 6.2 Three (3) races are scheduled. Additional races may be sailed as conditions permit.
- 6.3 The warning signal for each succeeding race will be made as soon as practicable. To alert boats of the next race, flag AP will be displayed with one (1) sound signal for at least two (2) minutes and will be lowered with one (1) sound signal one (1) minute before a warning signal of the first class is displayed.
- 6.4 The Race Committee boat on station at the finish line of a race will display code flag "R" if additional races are to follow (more than three races).
- 6.5 On Wednesday, August 7th, no warning signal will be made after 3:30PM.

7 CLASS FLAGS

- 7.1 Class flags will be used to designate classes for the purposes of starting, shortening course, and any other class dependent signals. When no class flags are displayed the signals apply to all classes.
- 7.2 Class flags will be:
 - Class 1 (Numeral One (1) on white background): Working Class Division
 - Class 2 (Numeral Two (2) on white background): Spinnaker Class Division
 - Class 3 (Numeral Three (3) on white background): Planing Class Division
- 7.3 Class 1, Class 2 and Class 3 may have simultaneous starts as determined by the Primary Race Officer and depending on the size of the fleet(s).

8 RACING AREA

8.1 Races will be held on Lake of the Woods in the area north of Ash Rapids or as directed by the PRO and as communicated at the Competitors' Meeting.

9 THE COURSES

- 9.1 The courses, including the approximate angles between legs, the order in which marks are to be passed, are illustrated in Appendix B of the Layover Day Sailing Instructions.
- 9.2 All boats will sail the same course.
- 9.3 All course marks shall be left to port.

10 MARKS

- 10.1 All course marks will be yellow or orange spheres.
- 10.2 A Race Committee boat signaling a change of a leg of the course is a mark as provided in Instruction 13.2.

11 THE START

- 11.1 The starting line will be between a staff displaying a RC flag on the race committee boat at the starboard end and the port end starting mark.
- 11.2 Races will be started as follows:

	Time to Start	Visual Signal	Sound Signal
Warning	5 minutes	Division Flag displayed	One Sound
Preparatory	4 minutes	Display of: P, I, Z, Z+I or Black Flag	One Sound
	1 minute	Lowering of: P, I, Z, Z+I or Black Flag	One Long Sound
Start	0 minutes	Lowering of Division Flag	One Sound

- 11.3 Divisions may be started in any order.
- 11.4 The warning signal for each succeeding class shall be made one minute after the starting signal of the preceding class.
- 11.5 Boats whose warning signal has not been made shall keep clear of the starting area.
- 11.6 A boat starting later than four (4) minutes after her starting signal will be scored Did Not Start (DNS). This changes rule A4.

12 RECALLS

12.1 Rule 29.1 will apply for Individual Recalls. The Race Committee may attempt to notify boats over early by hailing the sail number of each on the course side (OCS) boat. Delay or failure by the Race Committee to notify OCS boats shall not be used for grounds for redress. This changes Rule 41.

12.2 General Recall: The 'First Substitute' will be displayed with two (2) sound signals. The warning signal for class(es) recalled shall be made with or after the starting signal for the last scheduled class start. The timing sequence shall not stop. This changes Rule 29.2.

13 CHANGE OF THE NEXT LEG OF THE COURSE

- 13.1 To change the next leg of the course, the Race Committee will move the original mark (or the finishing line) to a new position and remove the original mark as soon as practicable. When, in a subsequent change a new mark is replaced, it will be replaced by an original mark. Any mark to be rounded after the new mark may be moved to maintain the course configuration without signaling.
- 13.2 Boats shall pass between the Race Committee boat displaying code flag "C" (and making periodic sound signals) and the nearby mark, leaving the mark to port and the Race Committee boat to starboard. This changes Rule 28.1.
- 13.3 Any change will be signaled before the leading boat has begun the leg, although the new mark may not yet be in position.

14 THE FINISH

14.1 The finishing line shall be between that point on the Race Committee boat displaying an "RC" flag (or an all blue flag) at the starboard end of the line and a mark (as described in Instruction 10.1.1) at the port end of the line.

15 TIME LIMIT

- 15.1 If no boat properly rounds the first mark of the course within 30 minutes of her start, the race will be abandoned.
- 15.2 If no boat properly finishes the course within 90 minutes of her start, the race will be abandoned.
- 15.3 Boats failing to finish within 30 minutes of the first boat to properly finish the course of the same class will be scored Did Not Finish (DNF). This changes Rules 35 and A4.

16 PROTESTS AND REQUESTS FOR REDRESS

- 16.1 Protest forms are available from the PRO on the RC boat. Protests shall be delivered there within the protest time limit to the PRO on the RC boat.
- 16.2 For all class, the protest time limit is 60 minutes after the Race Committee has returned to the Competitors' Meeting area following the last race of the day. The same time limit applies to protests by the Race Committee about incidents they observe in the racing area and to requests for redress. This changes Rules 61.3 and 62.2.
- 16.3 Notices will be posted within 30 minutes of the expiration of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the Competitors' Meeting area beginning at the times and/or order indicated in the notices.

- 16.4 Notices of protests by the Race Committee will be posted to inform boats under Rule 61.1(b).
- 16.5 Breaches of Instructions 11.4, 18, 19, and 20 will not be grounds for a protest by a boat. This changes Rule 60.1(a). Penalties for these breaches may be less than disqualification if the Protest Committee so decides.
- 16.6 After the last race of the regatta a request for reopening a hearing shall be delivered: within the protest time limit if the party requesting reopening was informed of the decision on the previous day; no later than 30 minutes after the party requesting reopening was informed of the decision on that day. This changes Rule 66.
- 16.7 Decisions of the Protest Committee will be final as provided in Rule 70.4.

17 SCORING

- 17.1 The Low Point scoring system will apply.
- 17.2 The boat with the shortest corrected finishing time will place first, the boat with the next shortest corrected finishing time will place second, and for each place thereafter add one position. Boats with equal corrected finishing times, to a precision of 1 second, will be tied.
- 17.3 One (1) race is required to be completed to constitute a series. Each boat's total series score shall be calculated as follows:
 - a) If three (3) or fewer races have been completed, each boat's series score will be the sum of her scores for all races:
 - b) If between four (4) and seven (7) race have been completed, each boat's series score will be the sum of her scores for all races excluding her worst score; and
 - c) If eight (8) or more races have been completed, each boat's series score will be the sum of her scores for all races excluding her two (2) worst scores.

18 SAFETY REGULATIONS

- 18.1 Each boat must have safety equipment as required by the Canadian Coast Guard and Transport Canada.
- 18.2 A boat that retires from a race shall notify the race committee as soon as possible.

19 RADIO COMMUNICATION

19.1 A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

20 PRIZES

20.1 Prizes will be awarded to the top three finishers in each fleet where there are at least five competitors. Permanent trophies will be awarded to the overall winners will be kept at Northern Yacht Club.

- 21.2 Competitors agree to hold harmless and keep indemnified LOWISA, Sail Manitoba and the Canadian Yachting Association (CYA), their sponsors, their organizers and their respective agents, officials, servants, and representatives, from and against all claims, actions, costs, expenses, and demands in respect to death, injury, loss or damage to the competitor's property, however caused, arising out of or in connection with Competitor's taking part in the event, notwithstanding that the same may have been contributed to or occasioned by the negligence of the same bodies, or any of them or their agents, officials, servants, or representatives. Competitors shall further understand and agree that this Release is binding upon them, their heirs, executors and assigns.




Course 1

Start - 1 - 2 - 3 - 1 - 3 - Finish




